TRAINER REGISTRATION CRITERIA

The following are minimum standards for each level.

LEVEL 5

- 18 years old
- Background investigation
- Registered with ENYYSA and in good standing
- "D" License or NSCAA National
- 5 year playing or 10 years of coaching experience

LEVEL 4

- 21 years old
- Background investigation
- Registered with ENYYSA and in good standing
- "C" License or NSCAA Advanced National or played with National Team, MLS, A-League or D3
- 1 year coaching experience on any level
- 7 years playing experience including 3 years of college or senior ball

LEVEL 3

- 21 years old
- Background investigation
- Registered with ENYYSA and in good standing
- "B" License or recognized foreign National license
- 3 years coaching experience on any level
- 8 year playing experience including 3 year college or senior ball

LEVEL 2

- 21 years old
- Background investigation
- Registered with ENYYSA and in good standing
- "A" License or recognized foreign National license
- 5 years coaching experience on 4 (four) of the following levels: youth, senior, college, ODP, professional (D3 and up), Club, League and State Directors of Coaching
- 10 years playing experience including 4 years of senior, college and D3 and higher

LEVEL 1

- 21 years old
- Background investigation
- Registered with ENYYSA and in good standing
- "A" License or recognized foreign National license
- 8 years of coaching on 5 (five) of the following levels: youth, senior, college, Regional Team, National Staff, National Team, A-League, MLS
- 10 years playing experience including 6 years senior, college, and D3 and higher
